ABOUT THE CONFERENCE

Background

There is a shift of paradigm in the health care services in which the focus of services is in a holistic point of view instead of the diagnosis of disease and treatment (Cohen, 1996). This paradigm shift brings a more advanced position for nurses in delivering the care. Literature mention that around 40% -75% of hospital services are nursing services (Gillies, 1994, in Swansburg & Swansburg, 1999) and almost services of health promotion and disease prevention both in hospitals and other health care settings was run by the nurses. This condition is being a concern of the government, associations, organizations, and educational institutions in graduating professionals in health care services. To meet the demands of the society of which critically evaluating the quality of nursing services in hospitals or the other settings.

Government policies through their regulations will have both direct and indirect impacts to the various agencies which involving in the establishment of the nursing profession standardization. That standardization aimed to ensure the community receives a high-quality care from a competent nurse. Implementation of the education is required to respond quickly to the challenges of globalization is a current issue. Therefore, nursing education must be able to produce graduates who are competent and capable of fulfilling the national and international standards (Nurhadi, 2004).

The learning process that supports the achievement in mastering nursing competence is covering three domains, namely attitude, knowledge, skill, and insight. These domains are expected to create a nurse graduate which well qualified and competitive (Nursalam & Ferry, 2008). The primary element in nursing education is how the learning process was managed in the field of practice. So far, the implementation of the clinical learning process in Indonesia is still needed special attention. There are still many problems that occur in clinical settings associated with the policy of the hospital or other health care facilities. For instance the ratio between clinical instructor and the number of students, the competence of clinical that have not been structured properly and collaboration between academic and clinical counselors which has not well developed. This problem might affect the quality of nursing education in Indonesia. Another phenomenon is the student still difficult to achieve the target of competence and the needs of the society parameters differentiation among vocational, bachelor and master education level (Antoni, 2012). Therefore the gait of Nursing Education Associations and Organizations is very helpful in the setting of nursing profession standards through professional education to achieve the quality of nursing competence. The packaging of a professional nurse requires an adequate learning process facility, whether in the classroom, laboratory, and clinical settings. Thus, the presence of nursing educational institutions, hospitals and clinics must support through the availability of the facilities, infrastructure and human resources such as providing preceptorship and clinical Instructor. It will strengthen the basics of science as a base for the activities of clinical practice, education, and the management of nursing (Ross, Mackenzie, & Smith, 2003).

THE EFFECTIVENESS OF A METHOD OF SIMULATION AND DEMONSTRATION IN THE EFFECTIVE COMMUNICATION TRAINING ON THE IMPLEMENTATION OF HANDOVER IN THE HOSPITAL OF PONTIANAK CITY

ABSTRACT

Background and Objective: Implementation of the handover is a routine activity that must be done as effective as possible by nurses in each shift. The accuracy of the information to be conveyed is so important to give continuity of nursing care that run properly. SBAR (situation, background, assesment, recomendation) communication is recomended by WHO to increase the effectiveness of communication. But, in fact there are still many the hospital have not applied the method of SBAR this well and properly, therefore the nurse need the socialization, because SBAR communication prove become an instrument effective in arrangement of nursing process. Method of socialization which are effective for communication SBAR can use the approach of learning simulation and demonstration method. Both methods can inform us the pupose is knowledge and psychomotor. The purpose is to review the effectiveness of a simulation and demonstration method in effective communication training on the handover in a few hospitals in Pontianak. **Method:** The research uses pre-experiment with pre-posttest design. The research will be conducted in hospital type c in the Pontianak city. The total samples are 42 team leaders and person in charge for the shift. The independent variables is the method of simulation and demonstration, and the dependent variable is the implementation of the handover. Sampling techniques is used simple randomize sampling with analysis of data that will be used is paired T-test. **Expected results:** Based on the literature review showed that the method of training simulations and demonstrations in effective communication, influence effect on the implementation of the handover
